ORDER:

In the reference read above, the Managing Director, Hyderabad Metro Rail has reported that Government vide G.O.Rt.No.214, Municipal Administration and Urban Development (H1) Department, dated 23.02.2010 have issued authorizing the Managing Director, Hyderabad Metro Rail Limited to short list the 8 (eight) Applicants as Pre-qualified bidders for issue of RFP and other Bid documents for submission of Financial bids for development of Hyderabad Metro Rail (MRTS) project. Accordingly, letters were issued to all the eight applicants as instructed by the Government.

2. Further, the Managing Director, Hyderabad Metro Rail Limited has reported that the model RFP document was converted into project-specific RFP, duly following the guidelines issued by the Ministry of Finance. Consequent to issue of RFP, the 6 companies/consortia have purchased the RFP and also attended the pre-bid meeting held on March 25, 2010. The Bid Due Date for receipt of Financial bids is July 14, 2010.

3. The Managing Director, Hyderabad Metro Rail Limited has further reported that Hyderabad Metro Rail has a three member Works Sub-Committee consisting of Secretary to Government (R&E), Finance Department and Director, Hyderabad Metro Rail; Managing Director, Hyderabad Metro Water Supply and Sewerage Board and Director, Hyderabad Metro Rail and Managing Director, Hyderabad Metro Rail Limited to scrutinize the proposals of major works (constituted by the Government vide G.O.Rt.No.1056, Municipal Administration and Urban Development Department, dated 21.7.2008). Earlier, this Sub-Committee was authorized by Government (Note approved by Chairman, Hyderabad Metro Rail & the then Principal Secretary, Municipal Administration and Urban Development Department, dated 03.10.2009) to receive, open and evaluate the RFQ Applications with the assistance of the consultants for the Project and submit it's recommendations to Government through Chairman, Hyderabad Metro Rail Limited.

4. The Managing Director, Hyderabad Metro Rail Limited has requested the Government to consider authorizing the Hyderabad Metro Rail Works Sub-Committee while following the same procedure as earlier to Receive, Open and Evaluate the RFP Bids as per procedure indicated in the RFP document with the assistance of the Evaluation Consultant M/s. Fortress Infrastructure Advisory Services; Technical Consultant M/s. Balaji Rail Road Systems Limited; Financial Consultant M/s. Deloitte Touche Tohmatsu India (P) Limited; and the Legal Consultant M/s. Luthra & Luthra and to put up its recommendations for consideration of the Government through the Chairman, Hyderabad Metro Rail Limited.

5. The Government after careful examination of the proposal of the Managing Director, Hyderabad Metro Rail Limited hereby constitutes the Committee to receive, open and evaluate the Request for Proposal (RFP) Bids as per procedure with the following:-

Hyderabad Metro Water Supply and Sewerage Board.
3. Managing Director,
Hyderabad Metro Rail Limited.

6. The Committee shall receive and open Financial Bids for Hyderabad Metro Rail Project and carry out the evaluation of the same with the help of Evaluation Consultant, M/s.Fortress Infrastructure Advisory Services; Technical Consultant, M/s.Balaji Rail Road Systems Limited; Financial Consultant, M/s.Deloitte Touche Tohmatsu India (P) Limited; and the Legal Consultant, M/s.Luthra & Luthra. The Committee shall submit recommendations to the Government for consideration of the Financial Bids through the Chairman, Hyderabad Metro Rail Limited.
