Terms and conditions:

1. The intending Bidders who are interested to take part in the Bidding in open Auction shall pay non refundable application fee of Rs. 2000/- in the shape of DD/BC drawn in favour of "Managing Director, Hyderabad Metro Rail" along with proof of identity of applicant.

2. The bidders must submit 25% of their bid value as Earnest money, in the shape of DD/BC drawn in favour of "Managing Director, Hyderabad Metro Rail, along with Bid. The Bids without Earnest money will be out rightly rejected.
3. The bidder shall have a minimum experience of equivalent area of Advertisement display in any of the Municipal Corporations/ Municipalities for any one year in the past three years.
4. The BID price shall invariably be equal to or more than Reserve Price. The Bids with Bid price less than Reserve Price will be out rightly rejected.
