- Contractors registered as Class V & above with the Telangana State Government are eligible to tender for the work. The Contractors shall upload their registration Certificates.
- EMD @1% of the Estimate Contract Value (ECV) shall be paid online.
- Latest Income tax return for F.Y 2022-23 (A.Y 2023-24), GST Certificate and PAN copy shall be uploaded along with tender.

4. Successful bidder shall pay EMD @1.5% of the Estimate Contract Value at the time of entering into agreement through DD drawn in favour of **Hyderabad Airport Metro Limited**.
5. The Managing Director, HAML reserves the right to reject any or all the tenders without assigning any reasons at any stage of the Tender process.
6. Existing commitments as per the format (statement-IV in the tender document), Annual turnover certificate for the years from 2019-20 to 2023-24 certified by CA shall be uploaded. The bidder shall satisfy the condition 2xAxN-B.
7. Tenders upto 25% less than the estimate contract value (ECV) may be accepted, but for tenders which are less by more than 25% of the ECV, a demand draft drawn in favour of **Hyderabad Airport Metro Limited** for the 85% of difference amount between the tendered amount and ECV should be submitted along with the tenders as additional security deposit (ASD).
8. The DDs towards EMD and (ASD, if applicable) shall be drawn on or after the date of publication of tender notification only.
9. The contractor should furnish the relevant experience certificate signed by not less than the rank of Executive Engineer to the effect that they have completed MS fabrication works such as MS grills / railings with MS angles, plates and equivalent materials of not less than 3000 Kgs in any single work in single year during the last ten financial years.
